

TOWN OF OAK GROVE, AR.  
TOWN COUNCIL MEETING MINUTES  
AUG. 7, 2001

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT; ALDERMEN EUGENE REYNOLDS AND SAM JONES. ALDERMAN GARY HIGH WAS ABSENT. ALDERWOMEN PAT HIGH AND VICKIE ALLEN AND RECORDER PAT CARLTON.

THE FIRST ORDER OF BUSINESS WAS THE READING OF JULY MINUTES. ANY CORRECTIONS OR OMISSIONS? ONE CORRECTION, GARY HIGH SHOULD HAVE BEEN THE ONE THAT SECONDED A MOTION IN THE PAYING OF THE BILLS INSTEAD OF EUGENE REYNOLDS. ALDERMAN SAM JONES MADE A MOTION TO ACCEPT AS READ AND CORRECTED, ALDERMAN EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS, THE BILLS WERE CHECKED AND INITIALED BY THE COUNCIL. A BILL FOR INSURANCE ON THE COMMUNITY BLDG. WATER SERVICE FEE AND THE BILL FOR THE WORK AND PARTS FOR THE P.C. WERE PRESENTED BESIDE THE REGULAR BILLS. ALDERMAN SAM JONES MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS, ALDERWOMAN VICKIE ALLEN SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S, OPPOSED BY THE SAME. NONE.

UNFINISHED BUSINESS: MAYOR MORGAN READ ORDINANCE #61-2001 FOR THE FIRST READING. ALDERMAN EUGENE REYNOLDS MADE A MOTION TO ACCEPT. ALDERMAN SAM JONES SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE. THE P.C. HAS BEEN FIXED

NEW BUSINESS: THE DEAD TREE AT THE COMMUNITY BLDG. NEEDS ATTENTION, CHECK WATER LINES FOR LEAK. WOULD LIKE TO GET THE COMMUNITY INVOLVED IN THE BEAUTIFICATION OF THE COMMUNITY GROUNDS.

ALDERWOMAN VICKIE ALLEN MADE A MOTION TO ADJOURN, ALDERWOMAN PAT HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.
