

TOWN OF OAK GROVE, AR.
TOWN COUNCIL MEETING MINUTES
DECEMBER, 4, 2001

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING DECEMBER 4, 2001, IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT; ALDERMEN SAM JONES, EUGENE REYNOLDS AND GARY HIGH. ALDERWOMEN PAT HIGH AND VICKIE ALLEN. RECORDER PAT CARLTON.

THE FIRST ORDER OF BUSINESS WAS THE READING OF LAST MONTHS MINUTES. ALDERMAN SAM JONES MADE A MOTION TO ACCEPT THE MINUTES AS READ. ALDERMAN EUGENE REYNOLDS SECONDED THE MOTION. ANY CORRECTIONS OR OMISSIONS? ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. THE BILLS WERE CHECKED AND INITIALED BY THE COUNCIL. ALDERWOMAN PAT HIGH MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS. ALDERWOMAN VICKIE ALLEN SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.

THE NEXT ORDER OF BUSINESS WAS THE RECONIZATION OF VISITORS. ECHO SAYER WAS PRESENT TO OFFER HER SUPPORT TO THE COMMUNITY AND TALKED ABOUT WHAT COULD BE DONE ABOUT DOGS RUNNING RAMPANT IN THE TOWN. HER DAUGHTER WAS KNOCKED OFF HER BICYCLE AND BITTEN BY A DOG. SHE WAS ADVISED TO CONTACT THE CONSTABLE OF OAK GROVE.

THE BUDET FOR THE WATER DEPARTMENT WAS PRESENTED TO THE COUNCIL. TOTAL OPERATING INCOME, \$45,000.00, TOTAL OPERATING EXPENSE, \$69,808.00, NET INCOME (LOSS), \$21,958.00. ALDERMAN GARY HIGH MADE A MOTION TO ADOPT THE BUDGET, ALDERWOMAN VICKIE ALLEN SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.

RECORDER PAT CARLTON FOUND TWO ORDIANCES WITH THE SAME NUMBER. SHE WAS TOLD TO MAKE THE CORRECTIONS (BY CONSENSUS).

ALDERMAN SAM JONES MADE A MOTION TO ADJOURN. ALDERWOMAN PAT HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.
