

TOWN OF OAK GROVE, AR.
TOWN COUNCIL MEETING MINUTES
NOVEMBER 7, 2001

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT; ALDERMEN EUGENE REYNOLDS, SAM JONES AND GARY HIGH, ALDERWOMAN PAT HIGH AND RECORDER PAT CARLTON. VICKIE ALLEN WAS ABSENT. THE FIRST ORDER OF BUSINESS WAS THE READING OF LAST MONTHS MINUTES. ARE THERE ANY CORRECTIONS OR OMISSIONS? ALDERMAN GARY HIGH MADE A MOTION TO ACCEPT THE MINUTES AS READ. ALDERMAN EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.

MAYOR MORGAN READ ORDINANCE 62-2001 FOR THE THIRD TIME. ALDERWOMAN PAT HIGH MADE A MOTION TO ADOPT THE ORDINANCE. ALDERMAN EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE. THE 2002 BUDGET WAS PRESENTED TO THE COUNCIL. ALDERMAN GARY HIGH MADE A MOTION TO ADOPT THE BUDGET. ALDERMAN SAM JONES SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE. MAYOR MORGAN IS TO SEE ABOUT RESURFACING PARAKEET LANE.

ALDERWOMAN PAT HIGH MADE A MOTION TO ADJOURN. ALDERMAN SAM JONES SECONDED. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.
