

TOWN OF OAK GROVE, AR.  
TOWN COUNCIL MEETING MINUTES  
OCTOBER 2, 2001

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT: ALDERMEN EUGENE REYNOLDS, SAM JONES AND GARY HIGH, ALDERWOMAN PAT HIGH AND RECORDER PAT CARLTON. ALDERWOMAN VICKIE ALLEN WAS LATE.

THE FIRST ORDER OF BUSINESS WAS THE READING OF LAST MONTHS MINUTES. ARE THERE ANY CORRECTIONS OR OMISSIONS? ALDERMAN GARY HIGH MADE A MOTION TO ACCEPT AS READ. ALERMAN EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. THE BILLS WERE CHECKED AND INITIALED BY THE COUNCIL. A BILL TO N.W. AR.ECONOMIC DEVELOPMENT WAS PRESENTED AND TO HOSTETTLER FOR THE ROOF FOR FIRE DEPT. #1. ALDERMAN EUGENE REYNOLDS MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS. ALDERWOMAN PAT HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.

IN UNFINISHED BUSINESS GARY HIGH IS TO TALK TO GARY MARSHALL ABOUT TAKING THE DEAD TREES OUT AT THE COMMUNITY BLDG. MAYOR MORGAN READ ORDIANCE #61-2001 BY TITLE ONLY FOR THE LAST TIME. ALDERMAN SAM JONES MADE A MOTION TO ACCEPT. ALDERMAN EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE. WE HAVE HAD NO ONE EXCEPT, DAVID WOODRING, RESPOND TO THE PAINTING OF THE WATER TOWER, DO WE WANT HIM TO GO AHEAD? ALL RESPONDED WITH A YES.

ALDERMAN SAM JONES MADE A MOTION TO ADJOURN. ALDERWOMAN VICKIE ALLEN SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.
