TOWN COUNCIL MEETING MINUTES
SEPTEMBER 4, 2001

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT: ALDERMEN EUGENE REYNOLDS, GARY HIGH AND SAM JONES, ALDERWOMAN PAT HIGH. ALDERWOMAN VICKIE WAS LATE. RECORDER PAT CARLTON.

FIVE I'S. OPPOSED BY THE SAME. NONE.
