TOWN COUNCIL MEETING MINUTES  
APRIL 2, 2002

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR. MET FOR A REGULAR MONTHLY MEETING APRIL 2, 2002, IN THE TOWN HALL.
