TOWN COUNCIL MEETING MINUTES  
FEB. 5, 2002

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING FEBRUARY 5, 2002, IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT; ALDERMEN SAM JONES, GARY HIGH AND EUGENE REYNOLDS, ALDERWOMEN PAT HIGH AND VICKIE ALLEN, RECORDER PAT CARLTON.

THE FIRST ORDER OF BUSINESS WAS THE READING OF LAST MONTHS MINUTES. ANY OMISSIONS OR CORRECTIONS? NONE. ALDERMAN EUGENE REYNOLDS MADE A MOTION TO ACCEPT THE MINUTES AS READ. ALDERMAN GARY HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. THE BILLS WERE CHECKED AND INITIALED BY THE COUNCIL. OTHER THAN THE REGULAR BILLS, A BILL FOR THE WATER DEPT. TO CAMERON INS. (CHECK OTHER INSURANCE COMPANIES AND SEE IF WE CAN GET A CHEAPER RATE.) ALDERMAN SAM JONES MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS. ALDERWOMAN VICKIE ALLEN SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE. THE COUNCIL AGREED THAT THE WATER DEPARTMENT ORDER THE NEW SOFTWARE FOR THE COMPUTER.

ALDERMAN GARY HIGH MADE A MOTION TO GIVE FIRE CHIEF, FRANK ALLEN, A SALARY OF \$100.00 A MONTH. ALERMAN SAM JONES SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE. ALDERWOMAN VICKIE ALLEN ABSTAINED FROM VOTING.

ALDERMAN SAM JONES MADE A MOTION TO ADJOURN. ALDERMAN EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.
