TOWN COUNCIL MEETING MINUTES
JANUARY 1, 2002

THE OAK GROVE TOWN COUNCIL, OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING JANUARY 1, 2002, IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT. ALDERMEN SAM JONES, GARY HIGH AND EUGENE REYNOLDS, ALDERWOMEN PAT HIGH AND VICKIE ALLEN AND RECORDER PAT CARLTON.

THE FIRST ORDER OF BUSINESS WAS THE READING OF LAST MONTHS MINUTES. ANY CORRECTIONS OR OMISSIONS? NONE. ALDERMAN GARY HIGH MADE A MOTION TO ACCEPT AS READ. ALDERWOMAN VICKIE ALLEN SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. THE BILLS WERE CHECKED AND INITIALIED BY THE COUNCIL. ALDERMAN SAM JONES MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS, ALDERMAN GARY HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.

NEW BUSINESS; THE COUNCIL WANTS THE CUT OFF DATE FOR UNPAID WATER BILLS TO BE THE 20TH OF EACH MONTH INSTEAD OF EVERY OTHER MONTH, IT WILL BE ADDED TO THE WATER RULES AND REGULATIONS. TELL RODNEY TO GET A GAS MASK FOR THE WATER BUILDING AND TO GET A LINE DETECTOR FOR THE WATER DEPARTMENT, ALSO ORDER A HYDRANT TEST KIT. ALDERWOMAN VICKIE ALLEN MADE A MOTION TO DO SO. ALDERMAN GARY HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE
