TOWN COUNCIL MEETING MINUTES
MARCH 5, 2002

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING MARCH 5, 2002, IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT; ALDERMEN EUGENE REYNOLDS, GARY HIGH AND SAM JONES, ALDERWOMEN PAT HIGH AND VICKIE ALLEN, RECORDER PAT CARLTON.

THE FIRST ORDER OF BUSINESS WAS THE READING OF LAST MONTHS MINUTES. ANY CORRECTIONS OR OMISSIONS? NONE. ALDERWOMAN VICKIE ALLEN MADE A MOTION TO ACCEPT THE MINUTES AS READ. ALDERMAN EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME, NONE.


THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. THE COUNCIL CHECKED AND INITIALED THE BILLS. ALDERWOMAN VICKIE ALLEN MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS. ALDERMAN SAM JONES SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.

THE NEXT ORDER OF BUSINESS WAS THE RECOGNITION OF DELEGATION. ECHO SAYER S AND SUSANNE NELSON WERE PRESENT. CONCERN ABOUT DOGS RUNNING LOOSE AND CONCERN ABOUT AMOUNT OF TIME IT TAKES FOR AN AMBULANCE TO REACH OAK GROVE.

MAYOR MORGAN GAVE HER REPORTS: HAVE BEEN CONTACTED BY RESIDENTS ABOUT FIXING THE BASKETBALL COURTS. AFTER SOME DISCUSSION IT WAS AGREED TO FIX THEM. GARY HIGH IS TO SEE ABOUT GETTING IT DONE.

WATER SUPERINTENDENT RODNEY NEWMAN WANTS TO KNOW IF THE COUNCIL WANTS HIM TO ATTEND THE SCHOOLING THAT IS OFFERED IN LITTLE ROCK, IT ALSO GIVES HIM HOURS FOR HIS LICENSE. THE COUNCIL AGREED THAT HE SHOULD GO AND THE WATER DEPARTMENT WILL PAY FOR IT.
