TOWN COUNCIL MEETING MINUTES
SEPTEMBER 9, 2002

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING ON SEPT. 9, 2002, IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT: ALDERMAN SAM JONES, GARY HIGH AND EUGENE REYNOLDS, ALDERWOMAN VICKIE ALLEN AND PAT HIGH, RECORDER PAT CARLTON.

THE FIRST ORDER OF BUSINESS WAS THE READING OF AUGUST MINUTES. ^{minutes} ANY WERE READ, MAYOR ASKED FOR ANY CORRECTIONS OR OMISSIONS, NONE. ALDERWOMAN VICKIE ALLEN MADE A MOTION TO ACCEPT THE MINUTES AS READ, ALDERMAN GARY HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S, OPPOSED BY THE SAME. NONE.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. THE COUNCILMEN CHECKED AND INITIALED THE BILLS. ALDERMAN SAM JONES MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS. ALDERMAN EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.

MAYOR MORGAN TALKED ABOUT HAVING A OPEN HOUSE FOR THE COMMUNITY TO SEE THE BUILDING THAT WAS DONATED TO THE TOWN AND NOW HOUSES THE TOWN HALL AND OFFICES. IT WAS DECIDED TO HAVE THE OPEN HOUSE BEFORE THE TOWN COUNCIL MEETING OCTOBER 1, 2002. RODNEY NEWMAN IS TO CLEAN UP BEHIND FIRE STATION #2.

ALDERMAN SAM JONES MADE A MOTION TO ADJOURN. ALDERWOMAN VICKIE ALLEN SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.
