

JOAK GROVE TOWN COUNCIL MEETING MINUTES
AUGUST 5, 2003

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING, AUGUST 5, 2003, IN THE TOWN HALL. THE NEXT ORDER OF BUSINESS: THE MAYOR AND COUNCIL DISCUSSED CLEANING UP AROUND THE COMMUNITY BLDG. GARY HIGH IS TO HAUL OFF METAL FENCE AND POSTS AND DO WORK ON WINDOWS AND ANY OTHER GENERAL CLEANING THAT NEEDS TO BE DONE. PAT HIGH WAS GIVEN PERMISSION TO ORDER CHRISTMAS DECORATIONS.
