

OAK GROVE TOWN COUNCIL MEETING MINUTES  
JULY 1, 2003

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING, JULY 1, 2003 IN THE TOWN HALL. MAYOR MORGAN CALLED THE MEETING TO ORDER AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT; ALDERMEN SAM JONES, EUGENE REYNOLDS AND GARY HIGH. ALDERWOMEN PAT HIGH AND VICKIE ALLEN. RECORDER PAT CARLTON.

THE MAYOR AND COUNCIL DISCUSSED THE STREET IMPROVEMENTS, BIDS FOR PAINTING THE COMMUNITY BLDG. AND THE ORDINANCE FOR LOUD NOISES INSIDE THE TOWN LIMITS WAS READ, THE COUNCIL THINKS IT NEEDS SOME CHANGES, WILL SEND BACK TO THE LAWYER FOR CHANGE.
