

OAK GROVE TOWN COUNCIL MEETING MINUTES
MARCH 4, 2003

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING, MARCH 4, 2003, IN THE TOWN HALL. MAYOR MORGAN CALLED THE MEETING TO ORDER AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT: ALDERMEN GARY HIGH, EUGENE REYNOLDS AND SAM JONES. ALDERWOMEN PAT HIGH AND VICKIE ALLEN. RECORDER PAT CARLTON.
