

OAK GROVE TOWN COUNCIL MEETING MINUTES
SEPTEMBER 2, 2003

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING, SEPT. 2, 2003, IN THE TOWN HALL. MAYOR JEAN MORGAN CALLED THE MEETING TO ORDER AND A QUORUM WAS ESTABLISHED.
