## TOWN OF OAK GROVE, AR. TOWN COUNCIL MEETING AUG. 3, 2004

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING AUG. 3, 2004 IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT; ALDERWOMEN PAT HIGH AND VICIKE ALLEN, ALDERMEN SAM JONES, EUGENE REYNOLDS AND GARY HIGH, RECORDER PAT CARLTON.

THE FIRST ORDER OF BUSINESS WAS THE READING OF JULY MINUTES. ANY CORRECTIONS OR OMISSIONS? NONE. ALDERWOMAN VICKIE ALLEN MADE A MOTION TO ACCEPT THE MINUTES AS READ, ALDERMAN EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I, FIVE I'S, OPPOSED BY THE SAME. NONE

STEVE ALLEN WAS PRESENT TO TALK ABOUT PUTTING POWER STEERING ON TWO OF THE FIRE TRUCKS, COUNCIL AGREED TO DO IT AS UPKEEP TO THE TRUCKS, STEVE ALSO TALKED ABOUT TWO YOUNG MEN THAT WANTS TO JOIN THE FIRE DEPT. AGES 16 AND 18. PAT WILL TALK TO MUNICIPAL LEAGUE ABOUT LEGALITIES.
