THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE MET FOR A REGULAR MONTHLY MEETING IN THE TOWN HALL, FEB. 3, 2004. THE MEETING WAS CALLED TO ORDER BY MAYOR MORGAN AND A QUORUM WAS ESTABLISHED. 

ORDERED TO BE PAID WITH GRANT MONEY. THE GENERAL FUND WILL PAY FOR THIS AND THE FIRE DEPARTMENT WILL RE-IMBURSE WHEN THE GRANT MONEY COMES IN . ALDERMAN GARY HIGH MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS, ALDERMAN EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.

AND \$7.00 PER HOUR FOR FUTURE WORK PLUS RE-IMBURSE FOR SUPPLIES. JEANETTE AGREED TO THIS. ALDERWOMAN VICKIE ALLEN MADE A MOTION FOR THIS PAY. ALDERMAN GARY HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE. ALDERMAN EUGENE REYNOLDS ABSTAINED.

ALDERMAN SAM JONES MADE A MOTION TO ADJOURN, ALDERWOMAN PAT HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME NONE.
