TOWN COUNCIL MEETING
SEPT. 7, 2004

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING SEPT. 7, 2004 IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT; ALDERMEN SAM JONES, EUGENE REYNOLDS AND GARY HIGH, ALDERWOMEN; PAT HIGH AND VICKIE ALLEN, RECORDER PAT CARLTON.

THE FIRST ORDER OF BUSINESS WAS THE READING OF AUG. MINUTES. ANY CORRECTIONS OR OMISSIONS? NONE. ALDERMAN SAM JONES MADE A MOTION TO ACCEPT THE MINUTES AS READ, ALDERWOMAN VICKIE ALLEN SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. THE BILLS WERE CHECKED AND INITIALED BY THE COUNCIL. BILLS FOR THE WORK DONE ON THE FIRE STATION #2, AMOUNTING TO \$1,784.84 WAS DISCUSSED. ALDERMAN EUGENE REYNOLDS MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS. ALDERWOMAN VICKIE ALLEN SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.

AFTER A DISCUSSION OF A PAY CHANGE ALDERWOMAN VICKIE ALLEN MADE A MOTION TO PAY GARY HIGH \$48.00 PER HOUR FOR BACK HOE WORK HE DOES FOR THE WATER DEPT. AND GIVE RODNEY NEWMAN \$37.50 FOR EACH METER HE SETS. ALDERMAN SAM JONES SECONDED THE MOTION. ALL IN FAVOR SAY I. THREE I'S. OPPOSED BY THE SAME, NONE. ALDERMAN GARY HIGH AND ALDERWOMAN PAT HIGH REFRAINED FROM VOTING. GIVE KAY JONES \$100.00 TO CLEAN THE COMMUNITY BUILDING FOR THE SCHOOL REUNION SEPT. 25TH. ALL IN FAVOR SAY I, FOUR I'S. OPPOSED BY THE SAME. NONE. ALDERMAN SAM JONES REFRAINED FROM VOTING.

ALDERWOMAN PAT HIGH MADE A MOTION TO ADJOURN. ALDERMAN SAM JONES SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.
