TOWN COUNCIL MEETING MINUTES
DECEMBER 6, 2005

THE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING, DECEMBER 6, 2005, IN THE TOWN HALL. MAYOR MORGAN CALLED THE MEETING TO ORDER AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT; ALDERMEN EUGENE REYNOLDS AND GARY HIGH, ALDERWOMAN PAT HIGH. ALDERMAN SAM JONES AND AND ALDERWOMAN VICKIE ALLEN WAS ABSENT.
