TOWN COUNCIL MEETING MINUTES
DECEMBER 05, 2006

THE TOWN COUCNIL FOR THE TOWN OF OAK GROVE, AR. MET FOR A REGULAR MONTHY MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT; ALDERWOMAN PAT HIGH, ALDERMEN SAM JONES, EUGENE REYNOLDS AND JOSH PEDEN. ALDERMAN GARY HIGH WAS ABSENT.

THE FIRST ORDER OF BUSINESS WAS THE READING OF NOVEMBER MINUTES. ALDERMAN JOSH PEDEN MADE A MOTION TO ACCEPT THE MINUTES AS READ, ALDERMAN SAM JONES SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. THE BILLS WERE CHECKED AND INITIALED BY THE COUNCIL. ALDERMAN JOSH PEDEN MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS, ALDERMAN EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.

RODNEY NEWMAN HAS PERMISSION TO GET A LEAF BLOWER AND TO GET SUPPLIES TO COMPLY WITH THE HEALTH DEPARTMENT FOR THE WATER DEPARTMENT. THE WATER DEPARTMENT IS TO CHARGE \$45.00 PER LOAD FOR WATER HAULED INSIDE TOWN LIMITS. \$15.00 TO DRIVER, \$15.00 TO WATER DEPT. AND \$15.00 TO FIRE DEPT(FOR GAS). \$60.00 PER LOAD OUTSIDE OF TOWN LIMITS. \$20.00 TO FIRE DEPT(FOR GAS). \$25.00 FOR DRIVER AND \$15.00 TO WATER DEPT. VOTED BY ACCLAMATION.

ALDERWOMAN PAT HIGH MADE A MOTION TO ADJOURN. ALDERMAN SAM JONES SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.
