TOWN COUNCIL MEETING MINUTES
FEBRUARY 7, 2006

THE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING, FEBRUARY 7, 2006, IN THE TOWN HALL. 
