TOWN COUNCIL MEETING MINUTES
JAN. 3, 2006

THE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING, JAN. 3, 2006, IN THE TOWN HALL. MAYOR MORGAN CALLED THE MEETING TO ORDER AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT; ALDERMEN SAM JONES, EUGÈNE REYNOLDS AND GARY HIGH, ALDERWOMAN PAT HIGH.
