TOWN COUNCIL MEETING MINUTES
APRIL 3, 2007

THE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR. MET FOR A REGULAR MONTHLY MEETING, APRIL 3, 2007, IN THE TOWN HALL. MAYOR MORGAN CALLED THE MEETING TO ORDER AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT; ALDERMEN SAM JONES, EUGENE REYNOLDS, GARY HIGH AND JOSH PEDEN. ALDERWOMAN PAT HIGH WAS ABSENT.

THE FIRST ORDER OF BUSINESS WAS THE READING OF MARCH MINUTES. ANY CORRECTIONS OR OMISSIONS? THE ALL IN FAVOR VOTE WAS CHANGED FROM FIVE I'S TO FOUR I'S. ALDERWOMAN PAT HIGH WAS ABSENT. ALDERMAN GARY HIGH MADE A MOTION TO ACCEPT THE MINUTES AND THE CHANGE, ALDERMAN EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. ALL OPPOSED BY THE SAME. NONE.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. THE BILLS WERE CHECKED AND INITIALED BY THE COUNCIL. THE BILL, \$3,400.00, THE CAR FOR THE WATER DEPT. WAS PRESENTED. ALDERMAN JOSH PEDEN MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS, ALDERMAN SAM JONES SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.



THE NEXT ORDER OF BUSINESS WAS THE RECOGNITION OF DELEGATION. RICK LESH AND RICK ADKINS WAS PRESENT TO PRESENT ONE HUNDRED AND ELEVEN SIGNED PETITIONS FROM PROPERTY OWNERS FOR A REQUEST THAT THE OAK GROVE FIRE DEPARTMENT CONSIDER THE CONSTRUCTION OF A SUBSTATION ON COUNTY ROAD 663.

THE NEXT ORDER OF BUSINESS WAS TO INCREASE THE PAY FOR THE CONTRACT WORK, FOR THE TOWN, TO \$7.50 PER HOUR, STARTING WITH THE APRIL PAY PERIOD. ALDERMAN EUGENE REYNOLDS MADE THE MOTION, ALDERMAN GARY HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE. GARY HIGH NEEDS A WATER PUMP TO USE FOR HIS BUSINESS, NEEDS ONE TO USE FOR THE WATER DEPT. AND FIRE DEPT. HE ASK IF THE COUNCIL WOULD ALLOW THE TOWN TO SHARE THE COST OF THE PUMP. THE SHARE WILL BE \$200.00. ALDERMAN SAM JONES MADE A MOTION TO DO SO. ALDERMAN EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.

ALDERMAN SAM JONES MADE A MOTION TO ADJOURN, ALDERMAN JOSH PEDEN SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.
