TOWN COUNCIL MEETING MINUTES
AUG. 7, 2007

THE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR. MET FOR A REGULAR MONTHLY MEETING , AUG. 7, 2007, IN THE TOWN HALL. MAYOR MORGAN CALLED THE MEETING TO ORDER AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT; ALDERMEN JOSH PEDEN, GARY HIGH, EUGENE REYNOLDS AND SAM JONES.


