TOWN COUNCIL MEETING MINUTES  
FEBRUARY 6, 2007

THE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR. MET FOR A REGULAR MONTHLY MEETING FEBRUARY 6, 2007 IN THE TOWN HALL . MAYOR MORGAN CALLED THE MEETING TO ORDER AND A QUORUM WAS ESTABLISHED.
