TOWN COUNCIL MEETING MINUTES

The Town Council for the town of Oak Grove, Ar. Met for a regular monthly meeting, Feb. 2, 2010, in the Town Hall. Mayor Morgan called the meeting to order. On roll call the following were present. Councilmen Sam Jones, Josh Peden, Eugene Reynolds and Gary High. Councilman Janice McKelvey was absent.

The first order of business was the reading of Jan. 5th minutes. Councilman Gary High made a motion to accept the minutes as read. Councilman Josh Peden seconded the motion. All in favor say I. Four I's. Opposed by the same. None.

The next order of business was the presentation of the bills. The bills were checked and initialed. Councilman Eugene Reynolds made a motion to allocate money to pay the bills. Councilman Sam Jones seconded the motion. All in favor say I. Four I's. Opposed by the same. None.

Mayor Morgan read Ordinance #80-2010. On the first reading Councilman Gary High made a motion to accept. Councilman Sam Jones seconded the motion. All in favor say I. Four I's. Opposed by the same. None. On second reading, by title only, Councilman Eugene Reynolds made a motion to accept. Councilman Gary High seconded the motion. All in favor say I. Four I's. Opposed by the same. None. On the third reading, by title only, Councilman Sam Jones made a motion to accept. Councilman Josh Peden seconded the motion. All in favor say I. Four I's. Opposed by the same. None.

The 2010 budget was presented to Council. The 2009 budget needs amending. The Administration from \$13,377.89 to \$16,000.00. The Fire Dept. from \$27,657.67 to \$33,255.00. The Street Fund from \$8,541.77 to \$12,250.00. Councilman Eugene Reynolds made a motion to accept. Councilman Gary High seconded the motion. All in favor say I. Four I's. Opposed by the same. None.

Six bids were handed in and presented to the council for the addition to the Fire Dept. building. Randall Dickinson, \$14,537.63, Greer Excavating \$15,550.00, Contractors Universe, \$12,231.00, Robert Lippe, \$10,480.00, Kevin Jones, \$9,000.00 and Leroy Barnes \$20,913.64. Contractors, Lippe, Jones and Barnes did not state specifications and all materials. Councilman Sam Jones made a motion to accept Randall Dickinson's bid, It was lower and met the needs of the building. Councilman Eugene Reynolds seconded the motion. All in favor say I. Four I's. Opposed by the same. None.

Councilman Sam Jones made a motion to adjourn. Councilman Josh Peden seconded the motion. All in favor say I. Four I's. Opposed by the same. None.
