TOWN COUNCIL MEETING MINUTES
MARCH 6, 2012

The Town Council of the Town of Oak Grove, Ar. Met for a regular meeting. The meeting was called to order by Interim Mayor Patsy Carlton and a quorum was established.

On roll call the following were present, Councilmen Gary Gray, Josh Peden. Gary High, Eugene Reynolds and Councilwoman Janice McKelvey.

The minutes for February 7th were read. Councilman Gary High seconded by Josh Peden made a motion to accept the minutes as read. All voted in the affirmative and the minutes were approved. The minutes for the February 14th special meeting were read. Councilman Eugene Reynolds seconded by Councilman Gary Gray made a motion to accept the minutes as read. All voted in the affirmative and the minutes were approved.

The first order of business was the presentation of the bills. The bills were checked and initialed. Councilman Gary Gray seconded by Janice McKelvey made a motion to allocate money to pay the bills. All voted in the affirmative.

The next order of business was the recognition of delegation. ^{Constable} Frank Dickinson was present. The Council talked to him about serving notices and certified mailings He can and will make every attempt to enforce town ordinances. Water superintendent Rodney Newman was present. The Council talked to him about schooling for his license. The water department pays for two nights at a hotel, gas for trip and license. Rodney will be paid for 24 hours travel time @ 9.00 per hour plus food expense. The schooling takes place at Hot Springs, Ar. Councilman Eugene Reynolds seconded by Josh Peden made a motion to accept. All voted in the affirmative.

FHA budget was presented to the Council. Councilwoman Janice McKelvey seconded by Gary Gray made a motion to accept. All voted in the affirmative.

Councilman Josh Peden seconded by Janice McKelvey made a motion for a judgment to be brought against Terry Klein for \$500.00 plus, against Terry Klein for a water bill over due. All voted in the affirmative.

Ordinance #87-2012 was read in entirety the first time. Councilman Gary Gray seconded by Josh Pden made a motion to accept the ordinance. All voted in the affirmative. Read by title only second time. Councilwoman Janice McKelvey seconded by Councilman Eugene Reynolds voted to accept. All voted in the affirmative. Read by title only for the third time. Councilman Gary High seconded by Councilman Eugene Reynolds voted to accept. All voted in the affirmative.

The final item, Councilman Eugene Reynolds seconded by Councilman Gary Gray made a motion to adjourn. All voted in the affirmative.
