TOWN COUNCIL MINUTES

THE TOWN OF OAK GROVE MET FOR A REGULAR MONTHLY MEETING JAN 2, 2016 AT THE TOWN HALL FOR A REGULAR MONTHLY MEETING. MAYOR PEDEN CALLED THE MEETING TO ORDER AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT, ALDERWOMEN SABRINA NANCE, LEAH MORGAN, JACKIE POWERS AND COUNCILMEN EUGENE REYNOLDS AND GUS WANDREY.
