TOWN COUNCIL MINUTES

MARCH 3, 2016

THE TOWN OF OAK GROVE MET FOR A REGULAR MONTHLY MEETING IN THE TOWN HALL. MAYOR PEDEN CALLED THE MEETING TO ORDER AND A QUORUM WAS ESTABLISHED. MAYOR PEDEN ASK TO STAND AND SAY THE PLEDGE OF ALLEGIANCE. *Peden (PC)*

(PC) ON ROLL CALL THE FOLLOWING WERE PRESENT, ALDERWOMEN LEAH MORGAN, SABRINA NANCE AND LEAH MORGAN, ALDERMEN GUS WANDREY AND EUGENE REYNOLDS.

AN AMENDMENT IS ADDED, DOGS ON A FARM WITH A MINIMUM OF 20 ACRES, UNLESS THAT DOG PRESENTS A DANGER OR A NUISANCE TO PEOPLE OR OTHER ANIMALS. ALDERWOMAN JACKIE POWERS SECONDED BY ALDERMAN GUS WANDRY MADE A MOTION TO ACCEPT. ALL VOTED IN THE AFFIRMATIVE.

THE NEXT ORDER OF BUSINESS, RON MC KELVEY WAS PRESENT WITH THE RE-NEW CONTACT FOR THE OAK GROVE SPEED WAY. THE COUNCIL WANTED TO BE SURE THAT MUFFLERS ARE ON THE CARTS. THEY WERE ASSURED THEY ARE. COUNCILWOMAN SABRINA NANCE SECONDED BY ALDERWOMAN JACKIE POWERS MADE A MOTION TO ACCEPT. ALL VOTED IN THE AFFIRMATIVE.
