

## **Oak Grove, AR**

### **City Council Meeting**

May 1, 2018

- Mayor Patsy Carlton called to order the meeting of the Oak Grove City Council at 7:PM on May 1, 2018 at Oak Grove City Hall. She asked all present to stand for the Pledge of Allegiance.
- Council members present: Jackie Powers, Eugene Reynolds, Gary Gray & Leah Morgan. Also, Present: Rhonda Brantner recorder.
- Rhonda Brantner read the minutes from the March 6<sup>th</sup>, 2018 meeting. Jackie Powers made the motion to accept the minutes, second by Eugene Reynolds. All agreed, and minutes were approved as read. There were no minutes to read for April, meeting was not held due to not enough council members present.
- March & April Monthly bills were presented. Jackie Powers made motion to pay bills second by Leah Morgan, all agreed.
- Monthly balance sheet for March was presented, April balance sheet was not available due to bank statements not in.
- Executive Session was called from 7:15-7:25 pm for discussion on Duane Malotte's interest to fill the position of the vacant council seat. Mr. Malotte was unanimously voted in to fill the vacant seat and was sworn in by Mayor Patsy Carlton.
- Rodney Newman approached council and told them that the state has advised that the city water tank is supposed to be inspected every 5 Years. He also stated that the tank had not been repainted since 2002 and would need to be repainted soon.
- Gary Gray made the motion to pay Rodney Newman for his time off from his job at Tysons while attending classes for the Water Dept. and 2<sup>nd</sup> by Eugene Reynolds, all agreed.
- Eugene Reynolds made the motion and 2<sup>nd</sup> by Gary Gray that The Fire Dept be reimbursed for meals when out on calls. Chief Allen will need to turn in those receipts for reimbursements.
- Noted that Pam Disheroon is retiring and a new accountant would need to be found.
- Regarding calls on CR 4351 needing to be graded, they need to be referred to the County Road Dept.

- Jackie Powers updated council on the Schoolhouse renovations. \$2707.00 was the bid for Heater & AC units. Motions was made by Gary Gray and 2<sup>nd</sup> by Duane Malotte to approve the purchase of the units. And Motion was made by Leah Morgan and 2<sup>nd</sup> by Gary Gray to check into the Historical Preservation Program for the old School House.
- Motion made by Gary Gray and 2<sup>nd</sup> by Leah Morgan to approve Linda's request for time off on July 3<sup>rd</sup>, 4<sup>th</sup>, & 5<sup>th</sup>.
- Fire dept reported that their radio problems had been repaired or had been replaced.
- Motion made by Eugene Reynolds to adjourn meeting, second by Duane Malotte. Meeting adjourned at 8:18 pm.
