
City Council Meeting

February 5, 2019


- Mayor Dwane Malotte called to order the meeting of the Oak Grove City Council at 7:00 PM on February 5, 2019 at Oak Grove City Hall. He asked all present to stand for the Pledge of Allegiance.
- Council members present Jackie Powers, Eugene Reynolds, & Gary Gray. Also Present: Rhonda Brantner recorder.
- Rhonda Brantner read the minutes for the January council meeting. Gary Gray made the motion to accept the minutes as read, second by Eugene Reynolds. All agreed and minutes for January 2nd, 2019 minutes were approved as read.

- Jackie Powers made the motion to approve funds to send Rodney to Aprils Continuing Education in Hot Springs, 2nd by Gary Gray. All Agreed.

- Dwane done a presentation on the City of Oak Grove Website at a cost of \$8.00 per month. Gary Gray made the motion that we continue with the website 2nd by Jayme Wambold. All Agreed.
- Steve Allen stated that Green Forest Fire Dept approached him about the sale of their Fire Truck to Oak Grove in exchange for the Graphics on their new vehicle. Gary Gray made the motion that we pay for the graphics on Green Forest new fire truck in exchange for their old truck 2nd by Eugene Reynolds. All Agreed.
