


Town of Oak Grove, AR
Town Council Meeting Minutes

July 5th, 2022

- ❖ Mayor Dwane Malotte called to order the regular meeting of the Oak Grove Town Council at 7:10pm at the Oak Grove Town Hall. All present asked to stand for the Pledge of Allegiance.
- ❖ Council Members present Jackie Powers, Terry Hutchison, and C. Elbert Standlee.
 - Absent: Jayme Wambold and Gary Gray
- ❖ Stephanie Shepherd read the minutes from the June 2022 meeting. Jackie Powers made motion to accept minutes, seconded by Elbert Standlee. All Agreed.
- ❖ Monthly Bills for June 2022 were presented. Motion made by Terry Hutchison to pay bills, seconded Jackie Powers. All Agreed.
- ❖ Preliminary Financial Statement for June 2022 were presented to Council.
- ❖ Mayor Dwane Malotte read for Second time Ordinance# 109-2022 permitting relatives of Town Officials and Employees to hold employment with the Town of Oak Grove. Motion Made by Elbert Standlee for approval of Ordinance, seconded by Terry Hutchison. All Agreed.
- ❖ Community wide letter to be sent concerning town ordinances in place reviewed by Council. Stephanie Shepherd to mail by July 12th.
- ❖ Terry Hutchison updated council that Bruce would be working on the fencing at the playground soon. Council discussed and agreed Street funds to be used for payment of invoice presented when materials are delivered. Terry Hutchison to provide invoice to Stephanie Shepherd after delivered.
- ❖ Jackie Powers announced that she will be retiring from the Town Council at the end of 2022.
- ❖ Jackie Powers discussed with Council the need to replace the missing caution markers located near a drainpipe. Council agree sign should be replaced. Jackie powers made motion to purchase new signs, Seconded by Elbert Standlee. All Agreed. Stephanie Shepherd to purchase signs.
