Ordinance No. 113-2023 for adjusting rates for service read by title only aloud by Mayor Fairweather. Motion made by Jayme Wambold to approve ordinance, seconded by Terry Hutchison. Gary Gray voted Aye. All Agreed. Ordinance approved, new rates to be implemented at next Billing cycle.
- Stephanie Shepherd informed the Council that she has confirmed Bank of 1889 is FDIC affiliated. After speaking with manager at bank, Stephanie confirmed the affiliation and wanted to inform council before any changes were made to town accounts.
